NO INCREASE IN GIFT LIMITATION FOR 2011 & 2012

The Political Reform Act restricts and in some instances even prohibits the receipt of gifts by public officials if the aggregate value of gifts received from that source during the calendar year exceeds the statutory amount, which is adjusted for inflation in odd-numbered years. The Fair Political Practices Commission, the agency charged with overseeing and enforcing the Act, recently determined that there would be no increase in the existing \$420 limit for calendar years 2011 and 2012.

Elected school and community college trustees, county superintendents of schools and members of county boards of education must observe this limitation with respect to <u>any</u> gifts, regardless of source, unless a statutory exemption applies. Public agency employees, on the other hand, are normally subject to the limitation only if they are designated as required to file Form 700 (Statement of Economic Interest) and if the agency's own conflict of interest code would require the reporting of a gift from that source. (Government Code section 89503).

Acceptance of a gift in excess of the statutory amount is not only a violation of the Act, it can prohibit the official from participating in any decision involving the donor. Board members and employees should refer to their local Conflict of Interest Codes for further details — for K-12 districts using CSBA templates, see Board Bylaw 9270.

The \$420 limitation applies to the <u>acceptance</u> of gifts. Lesser gifts valued at \$50 or more will still have to be <u>reported</u> by board members and designated employees on Form 700, unless an exception applies.

As reported in a prior School Law Update (November 2008), some gifts which incidentally benefit an individual may be exempt from these requirements if they meet specific criteria to be considered gifts to the agency. There are other specific exemptions in the law that may be applicable.
