In an effort to assist our clients in meeting this requirement, Schools Legal Service will provide the required training/education to both its JPA members and contract clients.

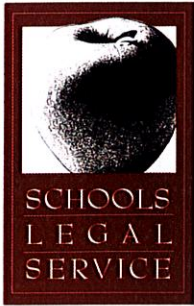
